Continuing Education for Caregivers: Training for Trainers – 3 NEW TRAINING TOPICS

This 3-hour virtual session introduces participants to over 30 hours of Caregiver Project training materials designed to prevent abuse and neglect, improve professional caregiving skills, increase quality of resident care and meet continuing education requirements for caregivers in settings regulated by DQA. Upon completion of the virtual sessions, participants will be able to train direct caregivers and other staff in their own entities. Cost is \$75 per participant.
